## UNJUST, UNREASONABLE: AARP ILLINOIS, CUB JOIN FRUSTRATED CUSTOMERS IN SPEAKING OUT AGAINST AQUA ILLINOIS' \$19M RATE-HIKE REQUEST AT PUBLIC FORUM

AARP Illinois and the Citizens Utility Board (CUB) on Monday urged state regulators to reject Aqua Illinois' proposed \$19.2 million rate-hike request, arguing that it was excessive, unjust and unreasonable at an Illinois Commerce Commission (ICC) public forum in Crystal Lake.

In January, Aqua, which serves about 273,000 customers in Illinois, filed for a \$19.2 million rate-hike request with the ICC (Docket # 24-0044) that could increase water/wastewater bills by as much as \$29.91 per month. Aqua's parent company, Essential Utilities, has raked in \$963.5 million in total profits over the last two years, and the utility last received a rate hike, of about \$7 million, in 2018.

Illinois American Water, another private water utility, has also filed for a rate hike, this one for \$152.4 million. The ICC is scheduled to rule on the rate-hike requests around November/December.

Aside from the escalating bills, Aqua's widely publicized service-quality issues have added to customer frustration, including unacceptable levels of lead in drinking water in University Park in 2019, a water outage in Lake County in 2023 and a boil order in July in Hawthorn Woods.

Responding to a request from AARP Illinois, the ICC scheduled five public forums on proposed private water increases this summer. Regarding Illinois American, there were forums in Jerseyville, Bolingbrook and Champaign. The ICC scheduled two forums for Aqua customers, including the one Monday night in Crystal Lake, and one scheduled for 7-9 p.m., Thursday, Aug. 1, Olivet Nazarene University, Wisner Auditorium, One University Ave., Bourbonnais.

"AARP Illinois requested these public hearings because Aqua customers deserve the chance to be heard on how this significant increase would impact them. Thousands of older customers, including those on fixed incomes, have written to tell us that these increases will mean they have to make tough choices between paying for water or paying for basic necessities like food and prescription drugs."

"We urge state regulators to reject Aqua Illinois' unjust and unreasonable rate-hike request. An increase of up to nearly \$30 a month would be a hardship for long-suffering Aqua customers, who are fed up with escalating bills and poor service. In its latest rate-hike request, Aqua exposes its true motive by pushing for an obscene profit rate for their shareholders. Clean, affordable water is a necessity, but Aqua has turned it into a profit tool. We urge state regulators to say no to Aqua."
